Energy security, a major driver of federal energy efficiency programs in the past, came back into play as oil and gas prices rose late in the year 2000. Also, worldwide emphasis on environmental problems of air and water pollution and global climate change, and the related development of clean energy technologies in western Europe and Japan especially, emerged in the 106th Congress as important influences on renewable energy policymaking. The Clinton Administration viewed renewable energy as the key part of its energy supply policy, both for environmental and technology competitiveness reasons. The FY2001 request for the Department of Energy's (DOE's) Renewable Energy Programs was \$454.8 million, an increase of \$92.6 million (32%) over the FY2000 level. This included \$409.5 million for DOE's Office of Energy Efficiency and Renewable Energy (EERE) and \$47.1 million to be managed by the Office of Science (OS). (See Table 2 at the end of this brief.) The FY2001 Energy and Water Appropriations bill that funds DOE's Renewable Energy Programs was incorporated into P.L. 106-377 .
